CLEANER HEAT. LOWER BILLS.

All New Yorkers deserve safe, reliable, affordable home heating and cooling and a livable future for our families. Outdated Public Service Law is preventing us from transitioning off of dangerous and expensive fossil fuels to efficient clean heating technologies. The NY HEAT Act offers a solution by aligning Public Service Law with our climate law while protecting consumers.

LOWER UTILITY BILLS

Every New Yorker deserves to stay warm and keep the lights on. But millions of New Yorkers are paying too much for energy and are behind on their utility bills. The NY HEAT Act will provide much needed relief by:

- Lowering bills up to \$75 a month for the New Yorkers who need it most
- Limiting utility bills to 6% of income, so struggling New Yorkers don't have to choose between heating and eating
- Ensuring no one is left behind during the transition to clean energy

FIGHT CLIMATE CHANGE

The climate emergency is an existential threat to all New Yorkers. Fires, floods, and extreme weather events are putting us in danger and costing us billions. The New York HEAT Act will put us on a path to a livable climate by:

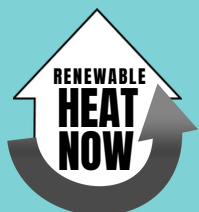
- Ending subsidies for building new, climate-destroying gas pipelines
- Enabling utilities to invest in modern, reliable, affordable technologies for heating and cooling such as heat pumps and thermal energy networks
- Slashing the state's largest source of climate-warming pollution: fossil fuels in buildings

GREEN JOBS AND HEALTHY HOMES

We all deserve clean air to breathe and a bright future for our children. The NY HEAT Act phases out fossil fuels that poison the air we breathe and creates tens of thousands of good green jobs by:

- Supporting investment in thermal energy networks, a massive jobs creator
- Facilitating a just transition for gas utility industry workers, creating clean energy jobs that use existing skills like pipefitting
- Eliminating sources of pollution that disproportionately impact lower income New Yorkers and communities of color.

Albany has not done enough to protect our families and seniors from predatory gas utilities. By including the NY HEAT Act in the one-house budgets, New York will take meaningful steps to advance our Climate Action Plan and protect consumers.

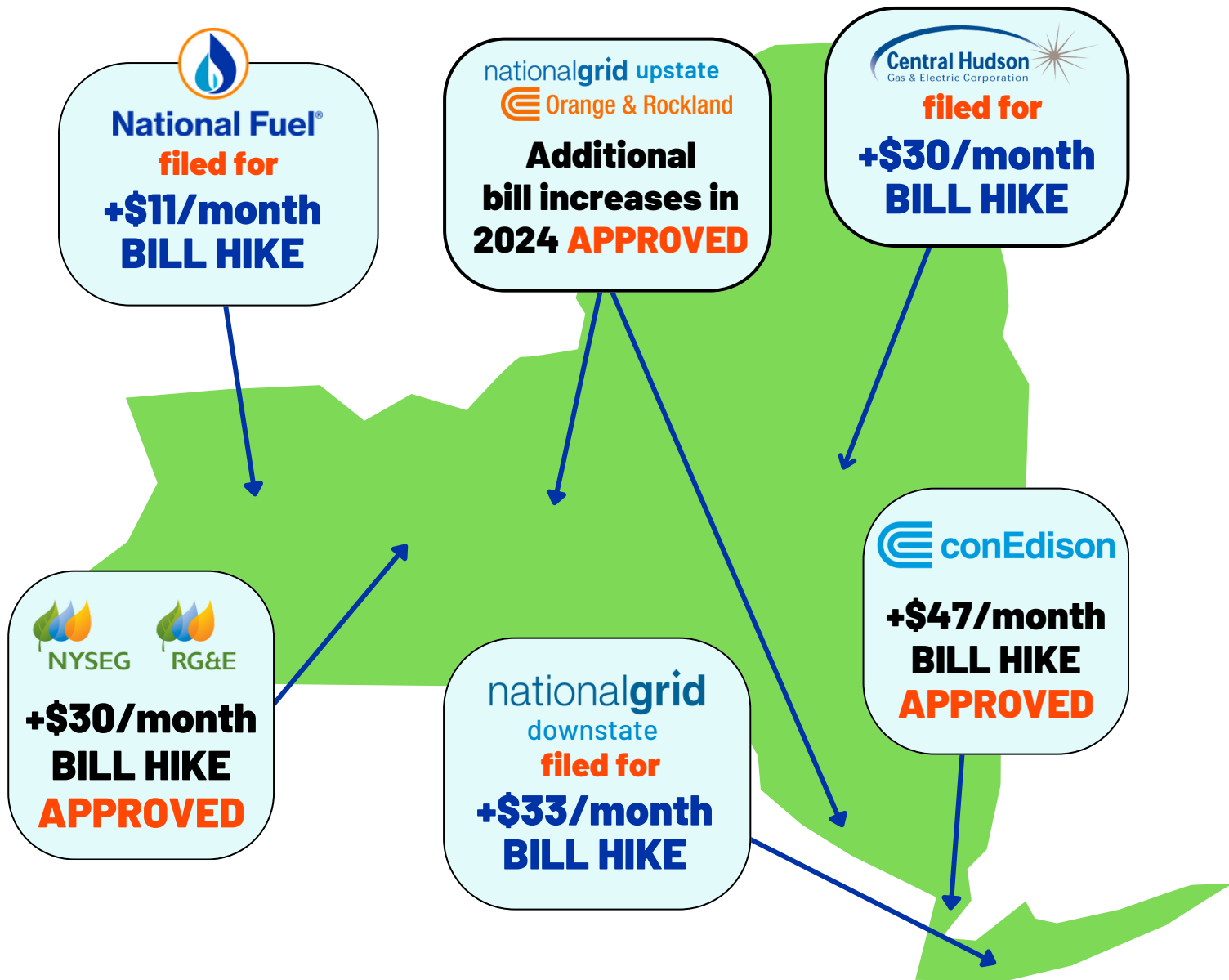
